# **Emeriti Association Legacy Grant**

Beginning in 2006, the Emeriti Association has awarded an annual grant to a JMU faculty member. When established, the grant was unanimously supported by the association's members and the grant rotates each year to a different JMU division. The dean of the selected division nominates a full-time tenured faculty member who does not hold an endowed chair or a funded professorship to receive the grant. Recommended uses of the grant are research, creative projects, travel related to professional development, enhancement of teaching, additional education, or other professor Newell Wright, Marketing (2006); Professor Raymond "Skip" Hyser, History (2007);

Professor Teresa Harris, Early Childhood Education (2008); Professor Ann Myers, Social Work (2009); Professor Hassan Hamdan, Mathematics and Statistics Department (2010); Associate Professor Don Rierson, Music Department (2011); Professor Scott Hammond, Political Science Department (2012); and Professor William (Bill) Wood, Economics (2013).

## **Unfunded Liabilities**

Phil Riley, a member of our Emeriti Association, has been in recent email contact with Robert Schultze, Director of the Virginia Retirement System, who warns that the Virginia Retirement System faces unfunded liabilities of \$28.14 billion.

"The primary causes of these liabilities," according to Schultze, "are twofold: the inability of the Virginia General Assembly to maintain regular and sufficient contributions into the fund each year and two major recessions since 2000 that reduced the value of VRS investments. While the latter has recovered, the former is subject to a plan adopted by the General Assembly whereby contributions to the fund will gradually increase until July 1, 2018, whereupon the General Assembly has pledged that it will fully fund annual contributions recommended by the VRS Board of Trustees and its consulting actuary."

To remedy unfunded liabilities, Schultze notes that "the General Assembly has made a number of revisions to the pension plan design that will reduce pension benefits for future retirees including:

- 1. Increased the age and service requirements so that members will have to work longer in order to achieve a full retirement benefit
- 2. Imposed a 5% member contribution for all state and local employees in the plan
- 3. Reduced the COLA formula for future retirees
- 4. Introduced a new hybrid plan for state and local employees hired on or after 1/1/14

These cost savings initiatives will take 8-10 years to generate substantial savings as new generations of state and local employees come under their provisions. We think that, so long as the General Assembly sticks with the long-term plan as outlined above, the unfunded liabilities will be gradually reduced to comfortable levels," concludes Schultze.

Phil encourages emeriti faculty to keep a watchful eye on the General Assembly's contributions to VRS, so that emeriti faculty can ensure that our elected representatives keep to the long term plan Schultze outlines. Thanks to Phil for this important VRS financial update.
