## JMU Faculty Senate Vision Grant Task Force Report

## The three parts of engagement:

- **Engaged Learning** Developing deep, purposeful and reflective learning, while uniting campus and community in the pursuit, creation, application and dissemination of knowledge.
- **Civic Engagement** Advancing the legacy of James Madison, the Father of the Constitution, by preparing individuals to be active and responsible participants in a representative democracy dedicated to the common good.
- **Community Engagement** Fostering mutually beneficial and reciprocal partnerships, ranging from local to global, that connect learning to practice, address critical societal problems and improve quality of life.

## The Vision Grant

- \$10,000 (give or take)
- Earmarked for Faculty Senate-associated initiatives for engagement (for any particular kind of engagement, or for multiple kinds of engagement at once)
- Possibility that the Grant can be renewed in the coming year(s)

## The Tasks of the VG Task Force:

- Raise awareness within the Faculty Senate about the new JMU Vision Statement, the three main aspects of engagement, and the purpose of the Vision Grant
- Collect and generate ideas for possible Vision Grant engagement initiatives
- Compile a general list of initiative ideas while recommending a short list of initiative ideas for special consideration
- Engage in some (but not all) research on how the shortlisted initiatives might be operationalized
