Charge:

Comprised of four Faculty Senate representatives, four academic administrators, and three ex-officio members, this joint task force will deepen and expand our collective understanding, expertise, and best emerging practices for activating shared governance across the range of activities, responsibilities, and areas in Academic Affairs and across campus.

2022-2023 goals include:

- Exploring current structures and existing practices
- Assessing communications strategies
- Collecting relevant research from a range of higher education experts
- Integrating JMU Climate Study results related to shared governance
- Proposing a plan to implement shared governance professional development opportunities including workshops, seminars, and/or guest speakers tailored to the JMU context

Summary of Current Semester Activity:

This new Task Force met five times over the course of the semester (see agendas below), beginning with a Q&A and delivery of the charge to the group, by Senate Speaker Kathy Ott Walter and Provost Heather Coltman. We then collaboratively developed operating agreements, built a working library of documents and resources in Microsoft Teams, and grounded our discussions in readings and research shared by ex officio member Ben

Selznick in a “state of the field” presentation. Members undertook multiple working sessions to generate and refine a list of concrete deliverables speaking to expressed faculty concerns, Senate Speaker suggestions, and each of the five goals outlined in our charge. The group also considered local application of a Shared Governance Assessment Tool created by the American Association of University Professors and used to produce national findings on “Faculty Roles by Decision-Making Areas” through the *2021 AAUP Shared Governance Survey*. Having agreed on possible deliverables, the Task Force then broke into small groups to make progress on them.

At our final meeting of the semester, we shared work in progress and small groups received feedback from fellow Task Force peers. Work is progressing on the following planned outputs:

- A resource library or broadly accessible “gateway” page for definitions and research-based best practices in shared governance, including draft language for possible adoption of a JMU campus statement on shared governance
- A “JMU policy library,” drawing together links to existing university and Academic Affairs policies relevant to shared governance
- A plan for documentation of current shared governance structures and communications practices in place at the campus and college level, to be created with faculty input
- A summary of findings relative to the state of shared governance at JMU from the September 2021 COACHE survey report (summarizing Spring 2020 feedback) and the April 2022 Campus Climate Study report (summarizing Fall 2021 feedback)
- Recommendations to create better documented and more trustworthy systems for voting, conducting surveys, and other faculty/staff feedback and data collection activities relevant to shared governance
- Recommendations for an action-oriented program for ongoing campus conversations, shared learning, listening, and concrete problem-solving around lived experiences of shared governance at JMU

Discussion continues on other possible recommendations and Task Force outputs.

Future Work Planned:

Bi-weekly check-in meetings are scheduled for the Spring semester and the group continues to seek a date or dates for an intensive working retreat. Consideration of a broad assessment tool or survey instrument has been tabled until Spring, pending further work by sub-groups. Members are continuing to progress their efforts toward the deliverables outlined above, which will be further workshopped with the whole Task Force beginning in February.

We anticipate a final report with a set of Task Force recommendations to Senate Steering and the Provost’s Office, along with the concrete deliverables outlined above, by the end of the Spring semester. Some deliverables — including draft websites and proposed plans for future programming or workshops — will require funding commitments, sustainability considerations such as maintenance/personnel commitments or decisions about ongoing “ownership,” and technology support.
