III. Provost's Report—Dr. Heather Coltman

- Congratulations to the new officers and to the Madison Vision Teaching Award winners: Amy Birdsong, Tim Howley, and Eric Imbrescia.
- The JMU community suffered a tragic loss with the death of sophomore Biology major Lauren Bennett. Everyone who needs help coping is encouraged to reach out and seek resources. Mental health issues continue to be a major priority.
- At the February townhall, there was a request to meet again. To follow up on mental health concerns, CFI will be sending out an invitation to [a presentation by Dr. Negar Shekarabi from UC Irvine](#). The event will be held via Zoom on Tuesday, May 17, at 3:30.

- In response to the Senate resolution from March about administrative transparency, the provost emphasized that she values collaboration with the Faculty Senate and that open lines of communication must be maintained. Shared governance positively impacts our collaborative work, and she's committed to that effort. Her written response is attached.
 - The 2021 hiring guidelines cannot be withdrawn because JMU is in the middle of hiring many positions and because the 2016 guidelines were not in compliance with OEO and HR.
 - The spring 2022 task force charged with making recommendations to revise the 2021 hiring guidelines is an exemplary model of such collaboration. A report of their work is expected at the end of May.
 - JMU is subject to the requirements of the Commonwealth; therefore, the provost can't commit to effecting changes when faculty are not on contract (e.g., the summer months). The timeframe simply may not allow for this. However, whenever possible, consultation with the faculty will be planned for, and during the summer months, the Steering Committee will be consulted.
 - The provost is committed to the model established by the hiring guidelines task force, which includes faculty and administration working jointly.
- The provost took the following questions:
 - Could time on a fixed contract count for faculty seeking the new lecture promotion?
 - Consult with your AUH and Dean. This question may be answered in the guidelines established by your department/college.
 - What is being done to address pay compression and inversion?
 - The Compensation Advisory Council is considering this matter. No concrete plan is currently in motion. The budget news out of Richmond impacts these efforts.

IV. Speaker's Report—Dr. Val Larsen

- The speaker congratulated Dr. Leslie Harlacker, who was elected Vice President of the Faculty Senate of Virginia. Her election is a credit to JMU and the attention we've given to adjunct concerns.
- The Climate Study results offer an important opportunity to address problems. The speaker encourages "co-branded initiatives"—joint efforts by the faculty and the administration—to identify problems, seek solutions, and implement programs.

V. Treasurer's Report

- Treasurer Cathy McKay reported a total of \$13,144.88. Since last month, one bereavement form has been processed for a total of 25 total this academic year. Thank you for using the bereavement form to honor the family members of your colleagues.
