## **U.S. BANK PREPAID CARDS**

TISH SHARED DETAILS REGARDING THE NEW U.S. BANK PREPAID CARD PROGRAMS IMPLEMENTED THIS PAST SUMMER TO REPLACE THE PREVIOUS BANK OF AMERICA PROGRAM. NEW TRAINING POWERPOINTS ARE AVAILABLE ON THE CASH AND INVESTMENTS WEBPAGE AND ARE REQUIRED OF ANYONE WORKING WITH THE CARDS WITH THE EXCEPTION OF STUDENT PER DIEM CARDS AND TEAM PER DIEM CARDS. CARD ORDERS AND FUNDING REQUESTS RECEIVED BY 11AM WILL BE PROCESSED THE SAME BUSINESS DAY. REQUESTS RECEIVED LATER WILL BE PROCESSED THE NEXT BUSINESS DAY.

#### **UPDATES AND REMINDERS**

MARK ANGEL ELABORATED ON THE REASON THE NEW APPAREL PROCEDURE AND LIMITATIONS WERE PUT IN PLACE. THIS IS BASED ON BOTH THE STATE CARDINAL MANUAL INDICATING THAT NON-UNIFORM CLOTHING PURCHASES FOR EMPLOYEES IS AN IMPROPER EXPENDITURE AS WELL AS IRS REGULATIONS THAT CLASSIFY APPAREL PURCHASES AS A TAXABLE BENEFIT. TISH REVIEWED THE NEW PROCEDURE AND RELATED EMPLOYEE APPAREL LOG. THE \$65/PERSON, PER YEAR IS BASED ON THE FISCAL YEAR.

**SUBMISSION OF THE OFF-CAMPUS AUTHORIZATION FORM:** THIS REQUIRES THAT A DETAILED AGENDA BE SUBMITTED ALONG WITH THE AUTHORIZATION FORM.

**CONFERENCE AGENDA'S WILL BE REQUIRED EFFECTIVE JANUARY 1, 2024.** THESE SHOULD SHOW THE DATES OF THE CONFERENCE, START AND END TIMES DAILY, AND MEALS INCLUDED.

**SPCC'S WITH A JUNE 2023 EXPIRATION DATE** WILL BE REPLACED IN EARLY JUNE. SPECIFIC DATES/TIMES/LOCATIONS WILL BE SHARED IN THE COMING WEEKS.

SEVERAL TIPS REGARDING COMMONLY OVERLOOKED ERRORS FOR ACCOUNTING VOUCHERS/INVOICES AND TRAVEL WERE REVIEWED.

PAYROLL REMINDER REGARDING COMMUNICATION AND COORDINATION AMONG DEPARTMENTS WHEN THEY ARE EMPLOYING INDIVIDUALS WORKING MULTIPLE HOURLY POSITIONS.

SPCC REMINDERS RELATED TO EXCEPTION REQUEST PROCESSING TIMELINES, MOST COMMON REASON FOR FLAGGED TRANSACTIONS AND HOW THE APPROVAL/REVIEW PROCESS WORKS WERE SHARED.

**REMINDER REGARDING THE \$100** DELIVERY MINIMUM WITH ARAMARK ORDERS. ANY FEE ADDED ON TO YOUR ORDER TO GET IT TO A TOTAL OF \$100 must be considered as part of the Per Diem, please keep this in Mind and consider other options for small orders.

**SPONSORSHIP LIMITS AND THE OUTGOING SPONSORSHIP JUSTIFICATION FORM:** THE LIMIT FOR BOTH STATE AND LOCAL FUNDED SPONSORSHIPS HAS BEEN INCREASED TO \$2,500 EACH. REMEMBER THAT THE OUTGOING SPONSORSHIP JUSTIFICATION FORM MUST BE SUBMITTED AND APPROVED PRIOR TO INITIATING PAYMENT. FAILURE TO DO SO MAY RESULT IN THE REQUIREMENT TO REPAY THE COST FROM NON-STATE FUNDS.
