DEADLINE FOR ACCEPTING 2020-21 LOANS IS APPROACHING

Federal Loans for the 2020-21 school year must be certified by the last day of the spring semester. This means loans must be accepted in MyMadison and/or an application submitted via www.studentaid.gov **before** the last day of th semester in order to be processed.

Deadlines to accept 2020-21 loans/submit an application: May 5th- Subsidized/Unsubsidized Loans May 4th - Parent/Graduate PLUS Loans

Students and parents must also continue to meet all other eligibility requirements to receive the loan funds, so acceptance before the last day of classes does not guarantee receipt of the funds. If the borrower is not meeting the eligibility requirements at the time of the disbursement, the loan will be canceled.

Under no circumstances can we process aid after the academic year has ended.

AWARD NOTICES FOR THE 2021-22 ACADEMIC YEAR

The process of generating Official Financial Aid Award Notices for the 2021-22 academic year generally begins in mid-June, after spring grades are finalized.

Two major reasons for this timing include needing spring grades to run the annual Satisfactory Academic Progress (SAP) process, as well as to allow time for academic records to be updated with statuses such as grade level progression, suspension, etc.

SAP and a student's academic standing are two critical components in determining financial aid eligibility.
