FINANCIAL AID ELIGIBLE HOURS

Federal regulations stipulate that schools can only consider classes that count towards your degree requirements when awarding financial aid. Classes that can be included when determining financial aid eligibility are those that:

- count toward your degree or general education requirements,
- are required for your major,
- are required for your minor, or
- fulfill your electives to reach a minimum of 120 credit hours.

In MyMadison, you will see a "Yes" or "No" under the "Eligible for Financial Aid" column in "My Class Schedule". A class with "yes" next to it will be considered when calculating your financial aid eligibility. Those with a "No" will not.

For example, if you are registered for 12 credits and 9 of them are marked with a "Yes" but 3 say "No," then you will be considered a 9-hour student for financial aid purposes.

REGULATORY CHANGE FOR VGAP

Beginning with the 2018-19 academic there has been a regulatory change in the eligibility criteria for renewing a Virginia Guaranteed Assistance Program (VGAP) grant.

The rules state that this grant can only be renewed when/if students' progress to the next grade level, and that a student cannot receive more than one VGAP award at each grade level.

For example, if you are awarded VGAP for fall 2018 and spring 2019 as a freshman but don't earn enough credits at the end of spring 2019 to be considered a sophomore in fall 2019, then you cannot receive VGAP for that term. Your VGAP eligibility can be renewed once you progress to a sophomore class level. If this progression happens in spring 2020, that begins your one year period of sophomore VGAP eligibility.

Please keep in mind that VGAP grants are not available during the summer term, so this aplies to fall and spring awards.

AUTHORIZED USERS

Students can provide access to an authorized user via MyMadison. Authorized users receive notifications sent out by the Business Office regarding outstanding balances, statements and 1098-T forms. More information can be found here:
