WITHDRAWALS AND "F" GRADES

As the deadlines for adding, dropping and withdrawing from classes approach, we want to take a minute and highlight how the decision to withdraw from one class or from all of your classes within a given term can affect your eligibility for financial assistance now and in the future.

Likewise, earning all "F" grades can affect your current and future eligibility.

To comply with federal regulations, the financial aid office may need to reduce or cancel previously disbursed financial aid. This immediate consequence could cause you to owe the university money.

For the future, withdrawing or earning "F" grades could result in your inability to meet Satisfactory Academic Progress (SAP) requirements.

PRIVATE/ALTERNATIVE LOANS

There are many things to consider before applying for a private/alternative loan. In most cases, federal student and parent loans are more cost effective and provide more consumer protections than private loans.

REPEATED COURSES

Federal regulations limit the number of times students can receive financial aid for repeating courses. Students may only receive financial aid for a course one more time after previously passing the same class with a grade of "D" or better.

This could affect your financial aid eligibility. For example, if you are registered for 12 credit hours and three of them are for a repeated course, your aid would be based on 9 credit hours.



SATISFACTORY ACADEMIC PROGRESS

All students must meet Satisfactory
Academic Progress (SAP) requirements to
receive financial aid. Federal regulations
require each institution to have a SAP
policy, which establishes the minimum
academic standards for financial aid
eligibility.

Your academic progress is measured once per year (after spring grades have posted). If you are unable to meet SAP requirements, you will lose your eligibility for federal financial aid, including grants, loans (both student and parent) and federal work-study.

You may appeal the SAP denial if you experienced extenuating circumstances.
