IV. New Business

A. Policy Discussion

1. Assistantships and Academic Warning

The main change in this policy is that students whose GPA falls below 3.0 will not be required to relinquish their graduate assistantship until their current contract expires.

Dr. Julie Carr made a motion to approve the policy changes, and Dr. Corey Hickerson seconded the motion. The voting members present approved the policy changes.

2. Transfer Credit

This proposed policy, with the support of the student's academic program, allows up to onethird of the program's required credit hours to be transferred from other universities. It also allows up to two-thirds of the required credits for a program to be completed at JMU before admission to that program.

Dr. Gubser motioned to approve the policy changes, and Dr. Knopp seconded the motion. These policy changes were approved by the voting members present.

The approved policy changes will be implemented immediately and reflected in the Fall 2024 catalog updates.

3. One Year Wait and Repeat, Forgive

Students who receive an F are discontinued and must wait one year before continuing their program. They must retake required courses if they choose to continue the program, but the F remains on their transcript and is calculated into their GPA. This makes it extremely difficult for the student to achieve the 3.0 GPA required for graduation. This policy change would allow students to **replace** the F with the new grade so that the F is not calculated into the GPA. The new policy would allow up to two repeat-forgive courses within the student's graduate career. It would be at the program's discretion to allow their students to utilize this policy.

Graduate Council members asked for more information regarding how many programs will want to allow this and what peer institutions are doing in this regard. They would also like to know how often students are dismissed from their programs and how often do they request to be readmitted. Michael and Laura will gather information to bring back to the Graduate Council for discussion.

Last year, programs were told that assistantships would be residency-neutral. Will this be the case for next year as well? Yes, we will continue to have the same policy. The assistantships must be offered early, especially for international students.

It was mentioned that graduate students need more on-campus housing. Dr. Stoloff confirmed there are plans for a graduate student housing facility to be built. We are unsure when this will come to fruition.

It was also mentioned that the Environmental Sustainability students need housing for the Fall semester, and the SLP online students need housing for six weeks in the Summer.

The next Graduate Program Director Assembly Meeting is scheduled for February 8. The main focus of the meeting will be international students.
