TIMELY NOTIFICATION BULLETIN

Possible Threat to the Community
"Your Right to Know"
October 28, 2010

OFFENSE: Home Invasion - Robbery LOCATION: 1100 Block of Harrison Street

TIME: Thursday, October 28, 2010, at approximately 3:30 AM.

SUSPECT(S): -Suspect #1 is described as a tall skinny black male, who was wearing a gray sweatshirt.

-Suspect #2 is described as a short, stocky black male, who was wearing a black

sweatshirt with a hood.

-Suspect #3 is described as a black male.

In compliance with the "Timely Notice" provisions of the federal *Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act of 1998* the Harrisonburg Police Department are giving notice of a incident involving a reported armed robbery at an off-campus residence.

The Harrisonburg Police Department is investigating an early morning home-invasion robbery. At 3:30 a.m. officers responded to the 1100 block of Harrison Street for the report of an armed robbery.

The three male victims reported that three unknown males entered the residence, displayed a handgun, and took electronics and other items from their home. Two victims were assaulted, one of which was transported to Rockingham Memorial Hospital with non-life-threatening injuries.

One suspect is described as a tall skinny black male, who was wearing a gray sweatshirt. Another suspect is described as a short, stocky black male, who was wearing a black sweatshirt with a hood. The third suspect is described as a black male. All three suspects had their faces partially covered.

This case is still being actively investigated by law enforcement. Members of the University community are urged to be vigilant and report any unusual circumstances and/or suspicious activities/persons immediately to law enforcement.

JMU and the City of Harrisonburg want to encourage everyone in the Community to exercise good crime prevention strategies all the time and to make these good daily habits. Close and Lock all exterior doors and windows at night and anytime the area is left unattended whether it be for 5 minutes or 5 days to go to class, go to the store, visit a friend or leave town for the holiday. Be particularly cautious about leaving ground level doors and windows unsecured and even individual room and office doors in complexes where multiple occupants have access to common areas inside the perimeter of the residential, administrative and academic facilities. This warning also extends to vehicles. Car windows should be up, car doors should be locked and valuable contents should be secured out of sight.

On-campus students are reminded to exercise safe practices in their dorms by keeping individual room and suite doors secured. Don't share access codes with anyone and do not allow unknown individuals to piggyback into exterior doors to residence halls when you come or go. You should always report lost or missing JAC cards and/or keys to University officials as soon as possible.
