1. If an individual is considered an “active member” of SGA then they will be required to attend at least **two (2) one (1) DEIJA-approved external events per semester** that promotes Diversity, Equity, Inclusion, and or Justice ~~hosted by a non-SGA club and or organization.~~
2. It will be the duty of the Diversity, Equity, Inclusion, and Justice committee and committee chairperson to inform non-committee members of upcoming events that pertain to DEIJA in and around the James Madison University community.
4. The activity shall be completed and submitted to the committee by **the Friday before finals week of each semester beginning fall semester 2023** ~~the Friday before the last senate of each semester beginning spring semester 2023.~~
