Approval of Minutes

Minutes from the meeting on Aug. 16, 2022 were unanimously approved. These will be posted to the SEA website.

Staff Emeriti membership:

- Member Update: 30 new members in 2022, including seven since the last Steering Committee meeting.
- Athletics Ticketing: Brad Burgess in Athletics Ticketing in late August was sent an Excel spreadsheet of staff emeriti who no longer use their JMU email. This is to be used by Athletics Ticketing to ensure those staff emeriti will be able to request tickets for football and basketball Faculty-Staff Appreciation Days. The SEA will notify its members via email about the Nov. 19 Appreciation Day football game *after* JMU has sent its general email on the event.
- Kognito training: A bulk email was sent to those with JMU eIDs regarding Kognito training, and it appears MyMadison access will be lost if individuals do not complete the training. An email was sent to vpstudentaffairs@jmu.edu indicating that JMU staff emeriti are not required to complete this training. A response has not yet been received.
