**Executive Summary**

James Madison University was established in 1908 as the State Normal and Industrial School for Women at Harrisonburg and became James Madison University in 1977. The Board of Visitors was established in 1964 and currently has fifteen members who serve on the board. Mr. Jonathan R. Alger serves as the sixth president of the university. The Board of Visitors met four times in 2022: February 18; April 22; September 16 and November 18. The Executive Committee met twice: June 22 and August 29. In addition, the board held a retreat on April 23 and heard a presentation from EAB on the future of higher education. The board also held a public comment period on the proposed tuition and fees on April 6, 2022.

The Board reorganized the committee structure of the board and now has the following committees: Academic Excellence, Advancement and Engagement, Athletics, Audit, Risk and Compliance; Finance and Physical Development, Governance, and Student Affairs. All of these committees, with the exception of the Executive Committee, meet during the regular scheduled board meeting schedule. The committees hear reports from various staff regarding current issues, new initiatives, and compliance with requirements and/or regulations.
