4. Pursuant to Section 2.2-3711.A.29, to discuss the award of public contracts involving the expenditure of public funds and discussion of the terms and scope of such contracts where discussion in open session would adversely affect the university’s bargaining position or negotiating strategy.

The motion was seconded by Nicole Wood and the Board moved into closed session. Following the closed session, Ms. Obenshain then stated the following:

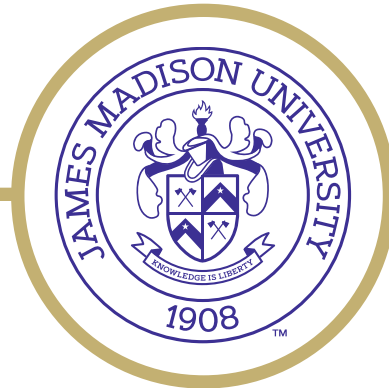

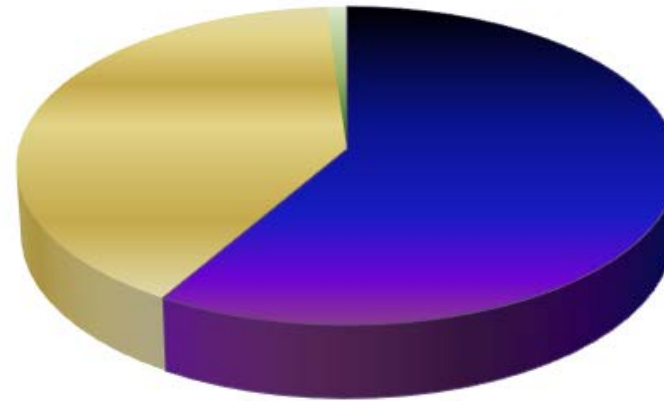

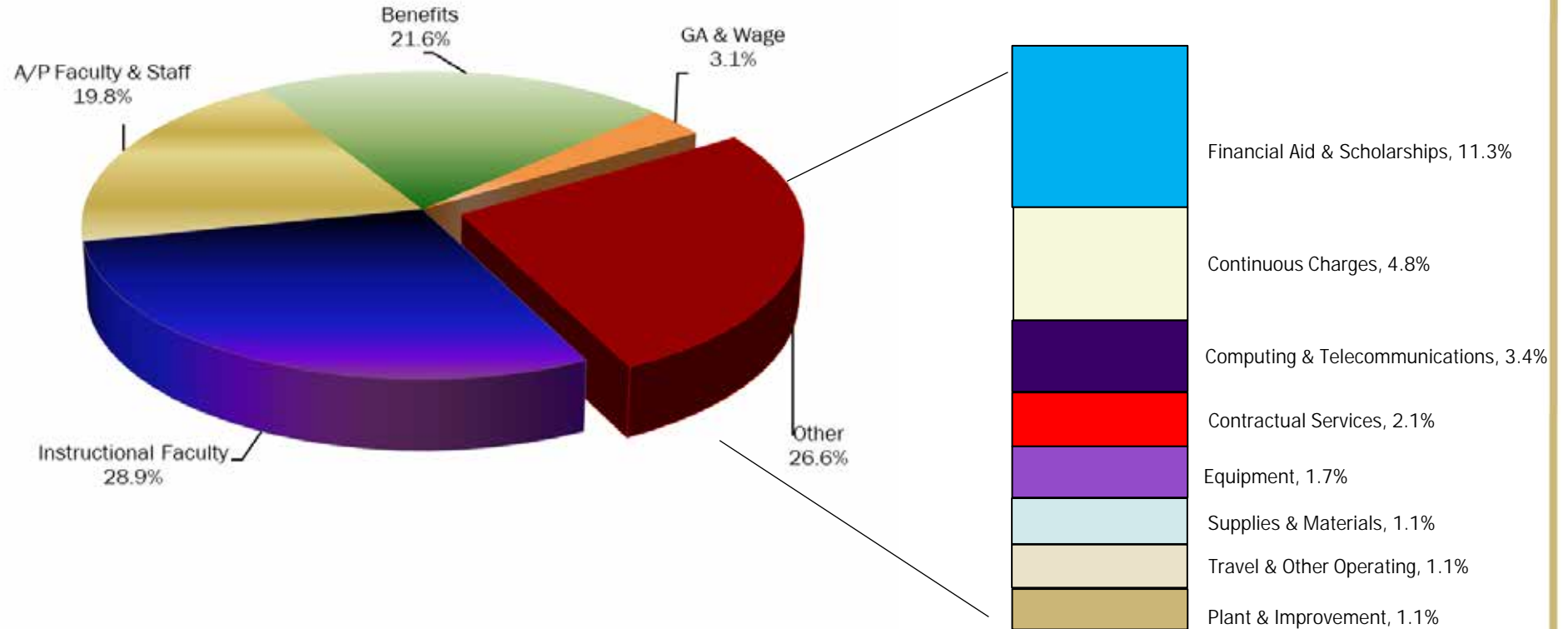

General Fund per Annualized In-State Full-Time Equivalent (FTE) Student & In-State Undergraduate Tuition/E&G Fees

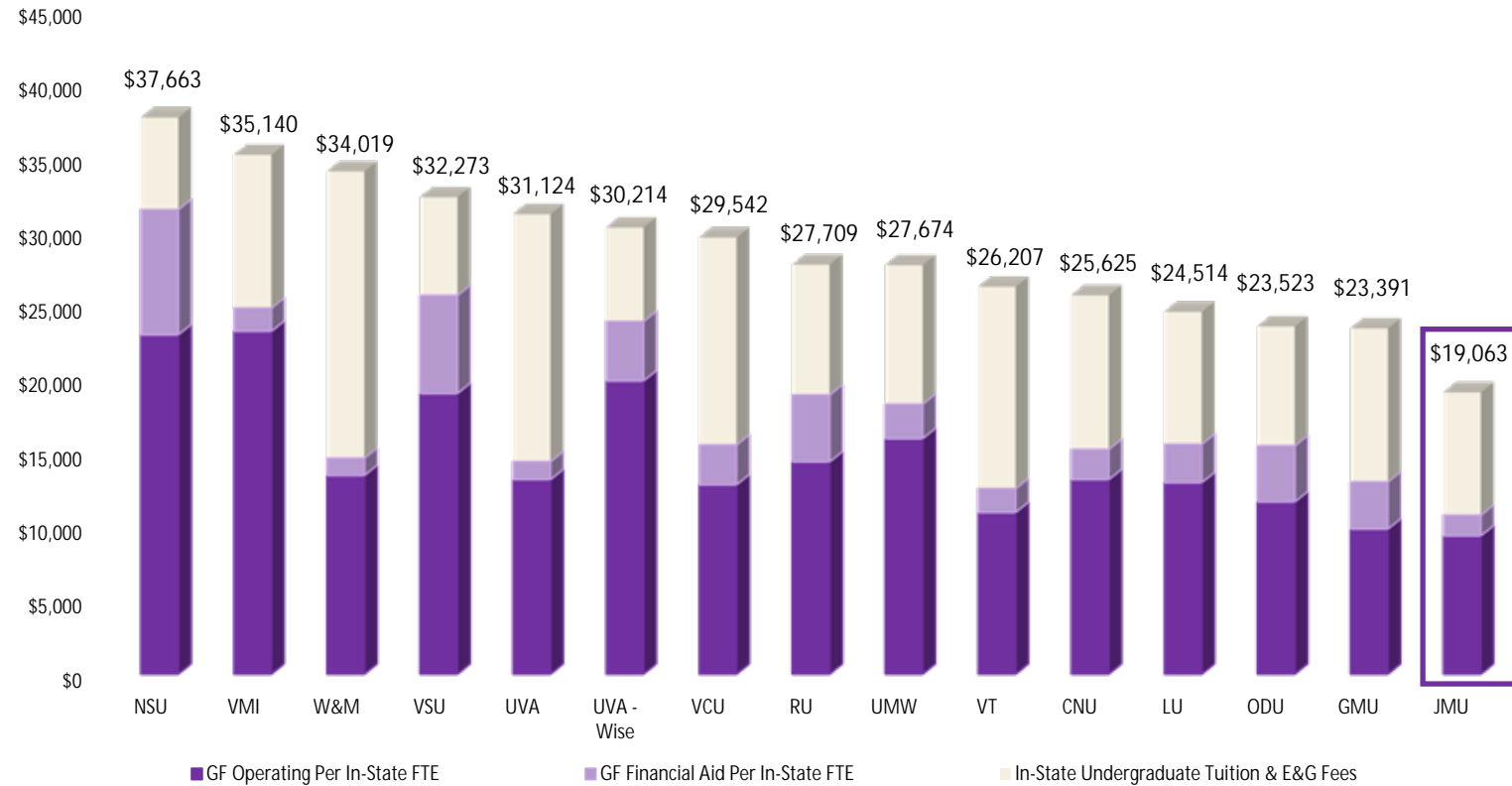

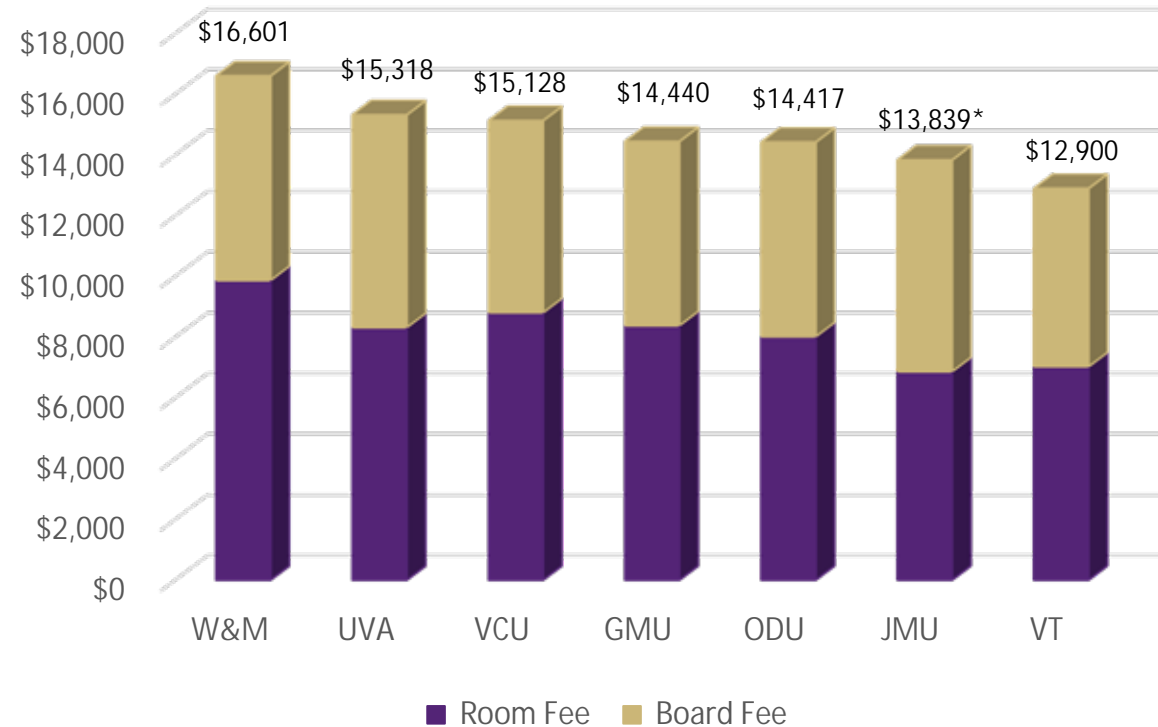

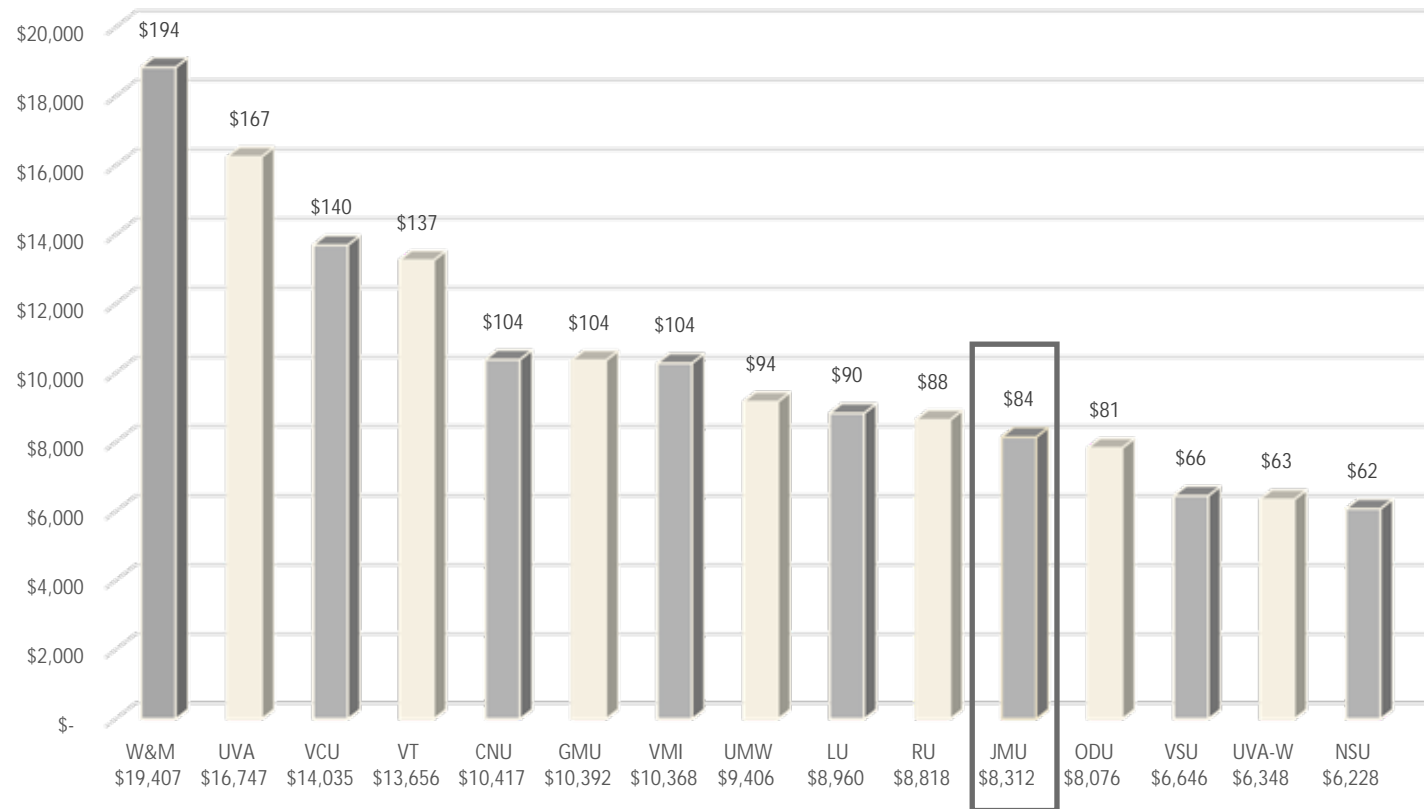

February

The revised Faculty Handbook was approved by the president, the Senate speaker, and the provost, and now awaits approval by the BOV. If approved, it will go into effect in the next academic year.

The Core Curriculum report was available for the vote by the faculty at the end of March. If approved, implementation will follow a slower timeline than originally intended, with partial implementation occurring in Fall 2027 and full implementation in Fall 2028.

The AI program *Einstein*, which can complete and submit coursework for students in Canvas, is drawing attention among faculty and administrators. Questions and comments about this issue pointed to liability, security risks, and ethical problems. The developer of Einstein received a cease-and-desist letter, and the site was taken down. This is likely to be a perpetual issue within higher education, and we must continue our conversations around AI.

March

With the approval of the new faculty handbook, faculty appeals will move out of the senate. Senate Steering will appoint the chair of that committee. The new Faculty Appeals Committee will be chaired by Kris Wiley, who has been appointed for a three-year term.

We are continuing our conversations around faculty workloads and recommending, at a minimum, that each department have an established workload policy.

Winners of the Madison Vision Teaching Award this year are David Brennan, Instructor, WRTC; Keith Grant, Associate Professor, Political Science; and Cyril Uy, Assistant Professor, Philosophy and Religion.

In the April Senate meeting, we will hold elections for the offices of speaker, speaker pro tempore, marshal, treasurer, and communications director.

We are continuing our conversations with REDI about information on its website and more details about who REDI is and what it does. The Research & Scholarship committee will continue to engage with REDI about the future of research at JMU.

The Shared Governance committee will continue its work to develop a list of best practices for deans and AUHs; this will be shared with the provost. It also continues to review and develop governance documents, including standard practices for voting. In the fall, the committee will work to develop a clear process for votes of no confidence, including having a process in place that is codified in the Senate Bylaws. A second item on that future agenda is integrating voting into the practices and culture of JMU. Departments should have written guidelines on who can vote and how the voting will take place.

There has been discussion of moving JMU's classification from R2 to R1; some faculty have raised concerns about space, faculty workloads, grant funding support not currently at the R2 level, and qualified support people recruited by other institutions. With federal funding cuts, it may be more difficult to attain R1 status. We would like a clearer definition of R2 at JMU and a plan on how we will work in this space first.

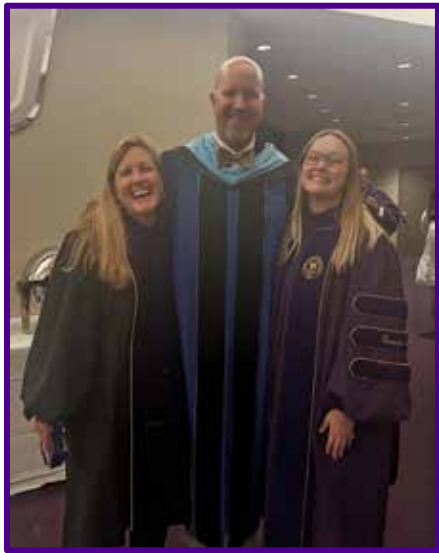

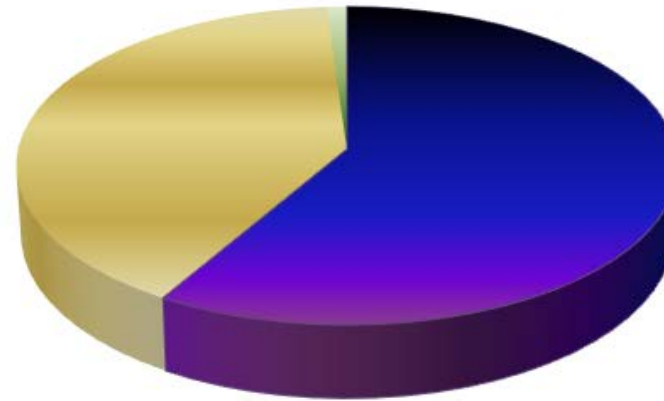

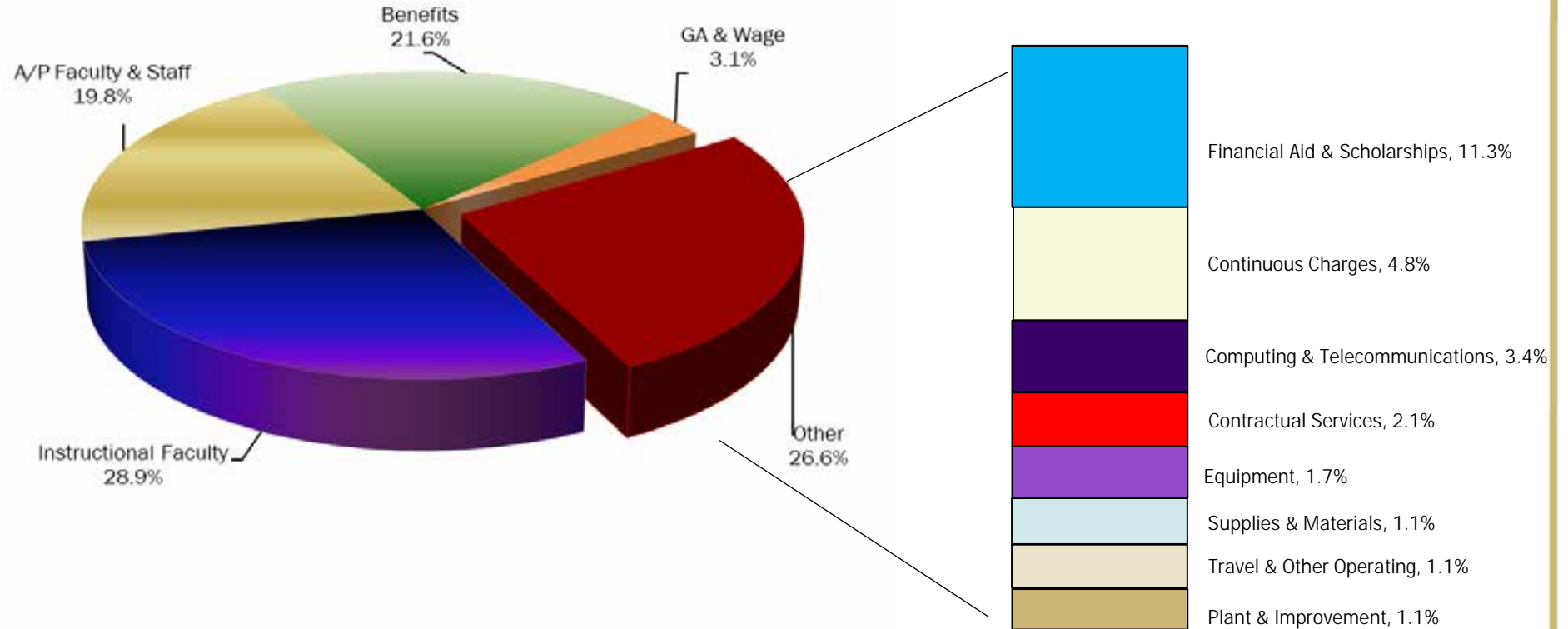

General Fund per Annualized In-State Full-Time Equivalent (FTE) Student & In-State Undergraduate Tuition/E&G Fees

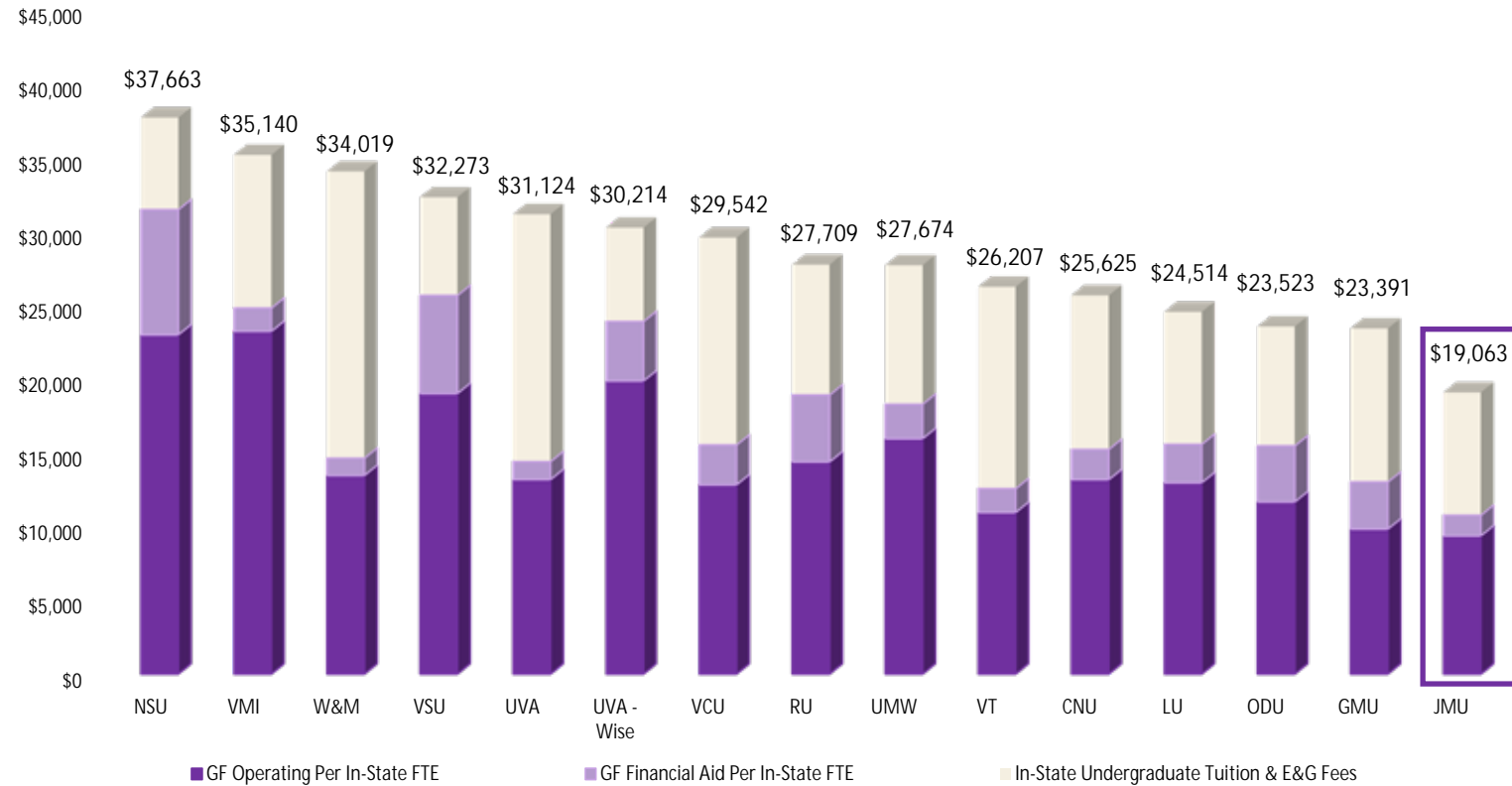

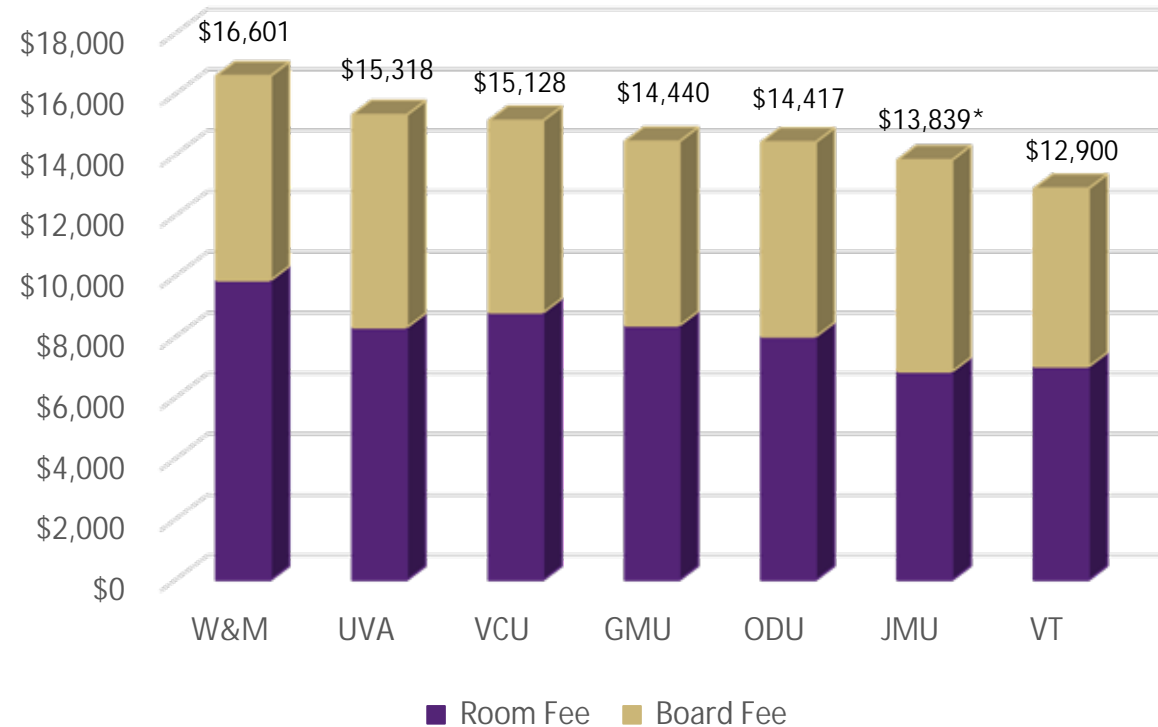

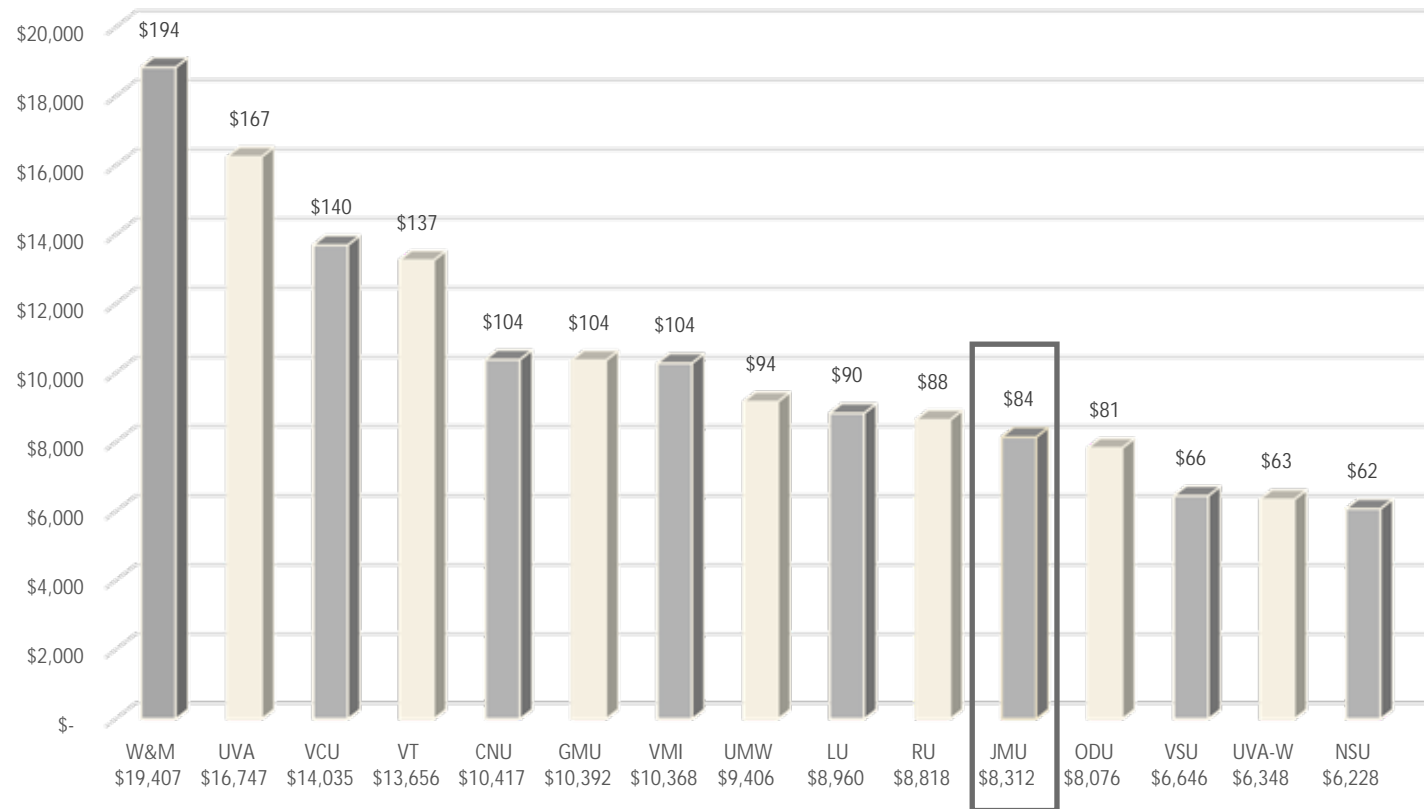
